

Maryland Steelworkers Credit Union Holds Annual Meeting

The 32nd Annual Membership Meeting will be held on Tuesday, June 12, 2001 at 7:00 p.m., at Local 2609, 550 Dundalk Avenue.

Being a Member-Owner of MSWCU provides you with a unique opportunity to vote for your Board of Directors and voice your concern in the operations of the Credit Union. One way for you to exercise your democratic right as a member is your participation in the annual meeting. Please plan to attend this year's meeting where you can meet your credit union officials, receive an update on the Credit Union's financial health and future objectives.

There are six Director positions available for election. All positions are for a 3-year term. To be eligible for election, you must be a Credit Union member in good standing for at least a five-year period.

Mr. Gordon Jakubowski and Mr. Gary Peacock have been appointed Chairmen of the Nominating Committee, which will nominate at least one member for each vacancy on the Board.

The Committee will file its nominations with the Credit Union secretary at least 45 days (April 27, 2001) before the Annual Meeting. These nominations will be posted in the Credit Union at least 40 days (May 3, 2001) before the Annual Meeting.

Nominations by members: Twenty (20) or more members may nominate candidates for directorship by signing a petition. The petition

must include a statement from each nominee that they agree to permit the nomination, and, if elected they agree to accept the office. The petition shall include printed names signatures and account numbers of all members signing, who must be in good standing with the Credit Union. Signatures on the petition must be legible so that membership can be verified.

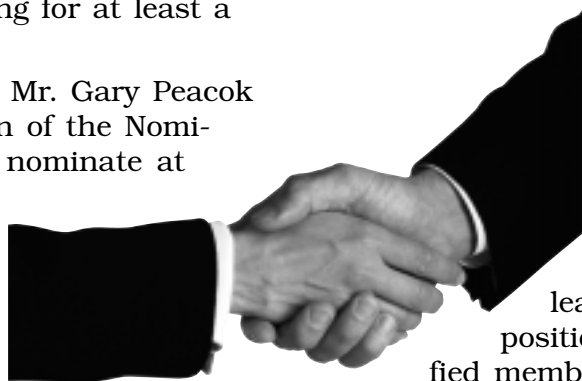

Petitions must be filed with the Secretary by May 11, 2001 before the meeting. The Secretary will post these nominations at the Credit Union office on May 21, 2001 before the Annual Meeting.

Nominations will be accepted from the floor **ONLY** if there is not at least one nominee for each position to be filled. Each qualified member (first named on the account - no joint owners) has one vote.

All club accounts will have one vote. The person representing that club account shall bring a letter for an officer of the club, which states the individual who is authorized to vote for that club.
